ORDER

As per the recommendation of the 9th Pay Revision Commission the Chief Electrical Inspector has submitted a proposal for creation of two posts of Deputy Chief Electrical Inspector each at Thiruvananthapuram and Kozhikode, one post of Junior Superintendent in the Meter Testing and Standards Laboratory, Thiruvananthapuram, upgradation of six posts of Junior Superintendents of the Chief Electrical Inspectorate as Senior Superintendents and to shift the posts to the District offices at Kollam, Alapuzha, Kottayam, Palakkad, Malapurram & Kannur and to upgrade the post of Head Clerk available in these six District Offices as Junior Superintendent and to shift them to the Chief Electrical Inspectorate and also to upgrade the posts of Head Clerk in the District Offices at Pathanamthitta, Idduki, Wayanad and Kasaragod as Junior Superintendent considering the increased work load in the report vide letter read above.

2) Government have examined the proposal in detail and are pleased to accord sanction for the creation / upgradation and shifting of posts in the Department of Electrical Inspectorate as follows-

i) Creation of two posts of Deputy Chief Electrical Inspector each at Thiruvananthapuram and Kozhikode while retaining the existing two posts

of Electrical Inspector and one post of Junior Superintendent in the Meter Testing Standards Laboratory functioning near the Government Engineering College, Thiruvananthapuram.

ii) 6 posts of Junior Superintendents in Electrical Inspectorate to be upgraded as Senior Superintendents and 10 posts of Head Clerk available in the district offices of Kollam, Alapuzha, Kottayam, Palakkad, Malapurram, Kannur, Pathanamthitta, Idukki, Wayanad and Kasaragod to be upgraded as Junior Superintendents.

iii) Six upgraded posts of Junior Superintendents in the Electrical Inspectorate will be shifted to the District office of Kollam, Kottayam, Alapuzha, Palakkad, Malappuram and Kannur and in turn the upgraded posts of Junior Superintendents of these districts will be shifted to the Chief Electrical Inspectorate.
